

MEMORANDUM OF AGREEMENT FOR THE 2014 EXTENSION TO THE 2010 WGA PUBLIC TELEVISION FREELANCE AGREEMENT

This Memorandum of Agreement (“Agreement”) is entered into between the Writers Guild of America, East, Inc. and the Writers Guild of America, West, Inc. (referred to as “WGA”), on the one hand, and WGBH Educational Foundation and Thirteen Productions LLC, on the other hand.

The provisions of the WGA-Public Television Freelance Agreement of 2010 (including all sideletters), shall be extended by this Agreement.

The terms and conditions set forth in this extended Agreement shall be subject to the terms of the 2010 WGA-Public Television Freelance Agreement except as modified herein:

1. Term of Agreement

Modify Article II of the WGA-Public Television Freelance Agreement of 2010 to reflect the two-year term of July 1, 2014, through June 30, 2016.

2. Amendment Language

All provisions of the WGA-Public Television Freelance Agreement of 2010 remain unchanged (and provisions which would have expired or sunset are continued in full force and effect) except as expressly modified herein.

All references to the WGA 2008 Theatrical and Television Basic Agreement (“MBA”) shall be amended to reference the 2014 MBA.

3. Minimums

All minimum rates set forth in the WGA-Public Television Freelance Agreement of 2010 shall be increased, compounded, as follows:

Two percent (2%) increase effective July 1, 2014.

Two and one-half percent (2.5%) increase effective July 1, 2015.

4. Execution


This Agreement may be executed in counterparts.


